INFORMATION

Dear Ladies and Gentlemen!

We would kindly like to inform you that flight schedule licences have to be applied for with the form provided on our homepage at least 30 days prior to the intended date of operation at Austro Control GmbH. Applications without completed form can only be accepted if all necessary information is provided in an appropriate way.

1. OPERATING CARRIER

Please indicate name, address and ICAO code of airline as well as a contact person and her contact information.

2. FLIGHT SCHEDULE

Community air carriers are entitled to operate intra-community air services without prior application for permit. The same applies to air carriers from countries deemed equivalent under an international agreement and air services to or from such countries (Regulation (EC) No 1008/2008).

For air services from or to third countries an approval is necessary for community air carriers and air carriers from third countries (§ 13 BGzLV - Federal Act on International Air Services 2008). Intra-community air services operated by air carriers from third countries are subject to an approval as well.

A permit is therefore necessary for

- Air services by intra-community carriers (or equivalent):

from Austria to third countries and vice versa;

- Air services by air carriers from third countries:

from Austria to third countries and vice versa;

- Air services by air carriers from third countries:

from Austria to member states of the European Union (or equivalent) and vice versa.

No permit is necessary for intra-community air services by community air carriers (or equivalent).

3. CODE SHARE ARRANGEMENTS

In case the air carrier operates flights on code share basis as an operating partner, all marketing partners have to be indicated.

Generally community air carriers (or equivalent) are entitled to operate intra-community air services without prior application.
