Enteisungs-Verfahren:

De-icing procedures:

- 1) Report the necessity for de-icing either to your ramp agent or to "SALZBURG ICE" on Tel: +43 (0)662 8580 2772. When announced on ATIS (normally on Saturdays), "SALZBURG ICE" is available on frequency 128.300 MHZ.
- 2) Forward requested Fluid/Mixture request to ramp agent.
- 3) Aircraft will be de-iced on parking stands.
- 4) Only when announced on ATIS, inform "SALZBURG DELIVERY/TOWER" before starting de-icing.
- 5) The "Clean Aircraft Concept" as defined in ICAO DOC 9460 is performed by Salzburg Airport Authority.

Verfahren und Einschränkungen der Flugsicherung:

ATC procedures and restrictions:

Auf Grund des hohen Verkehrsaufkommens gilt an Samstagen ab 22 DEC 2018:

1) Flight restrictions on Saturdays with effect from 22 DEC 2018:

- Sichtflüge haben mit Verzögerungen für An- und Abflüge zu rechnen.
- Sichtflüge, welche die CTR / TMA LOWS queren wollen, können abgelehnt werden.
- Sichtflüge sollten die Ankunft in Salzburg spätestens 30 Minuten vor ECET planen.

- VFR flights and IFR training flights have to expect delay
- VFR crossing clearance through CTR / TMA LOWS may be rejected
- VFR flights are requested to plan the arrival time for LOWS at latest 30 minutes prior ECET.

Folgende Flüge müssen mit der Flugsicherungsstelle Salzburg telefonisch koordiniert werden,

PPR is necessary for following flights:

- Tel: +43 (0)5 1703 6555
- Schulflüge (auch Helikopter Schwebübungen)
- Lokalflüge Salzburg-Salzburg mit weniger als 30 Minuten Flugzeit

- traffic circuit flights
- helicopter hover exercises
- local flights (departure/arrival LOWS, VFR and IFR) with a duration less than 30 minutes
- IFR training flights.

Ambulanz-, Rettungs-, Polizei und Militärflüge sind davon ausgenommen.

Verfahren der Flugsicherung:

ATC procedures and restrictions:

- 2) Speed restriction on Saturdays with effect from 22 DEC 2018 only from 0700 – 1900 UTC:
Arriving IFR flights which are not able to comply with a minimum speed of 160 KT to 5 NM final are normally not accepted within the mentioned time frame (based on ETA) due to dense arriving and departing traffic.

Exemptions from this restriction are ambulance, rescue, police and military flights.
- 3) Delivery Frequency:
Delivery Frequency "SALZBURG DELIVERY" FREQ 121.750 MHZ will be opened on demand and announced on ATIS "DELIVERY FREQ 121.750 OPEN".
(Especially on Saturdays from 15 DEC 2018 – 31 MAR 2019 "SALZBURG DELIVERY" will be in operation from 0600 until 2000 UTC).
When Delivery Frequency is opened, departing IFR-flights are requested to contact "SALZBURG DELIVERY" for any pre-flight information, IFR-clearance and start-up approval.
The request for start-up shall be made after all preparations for departure have been made (doors closed). On initial call for clearance and/or start-up report your parking stand.
Aircraft departing RWY 15 shall report if NOT able to depart from Intersection B and have to make a backtrack to use full RWY length.
Taxi clearance will be issued on Tower FREQ 118.100 MHZ.

Verfahren und Einschränkungen des Flughafens:

Aus Mangel an Parkpositionen müssen alle Flüge der allgemeinen Luftfahrt, welche am Samstag nach Salzburg kommen oder über das Wochenende in Salzburg parken wollen, spätestens 24 Stunden vorher bei der Flughafenbetriebsleitung eine Genehmigung einholen. Am Samstag ankommende Luftfahrzeuge der allgemeinen Luftfahrt dürfen maximal eine Stunde parken.

Airport procedures and restrictions:

- 1) Parking restrictions on Saturdays:
Due to lack of parking stands PPR for all General Aviation and non-schedule / non-charter flights on Saturdays, also for flights arriving on previous days and staying until Saturday.
Maximum parking time for such flights arriving on Saturday is restricted to 1 hour.
Permission/exemption has to be requested at least 24 hours prior to flight.
